#### SUPERVISOR COMMENTS

Swing shift had a steady call volume during the first half. Officers responded to a fight between two females. When they arrived one of the females was gone and not located or identified. The investigation revealed that the unknown female had stolen the victim's wallet and assaulted her in the process. The victim was taken to the hospital for treatment and the suspect, if identified, will be wanted for robbery. An officer saw a vehicle stopped in the roadway, and a female gathering items and walking away from it. She displayed signs of intoxication and was contacted. She was determined to be the driver and was arrested after a DUI investigation was done. The Sheriff's Department's Air 101 unit requested a TPD K-9 officer to assist CHP in a pursuit that was coming into the city. Our K-9 officer responded and was involved in the pursuit with CHP until it reached an area outside of our jurisdiction. We assisted CHP until a K-9 officer from another agency was able to relieve our officer. The suspect driver was ultimately arrested somewhere in the Modesto area, off of Hwy 99.
