Dayshift was busy most of the day. Early this morning, a gun was found discarded in a gutter near a school. School officials stood by with it until the officer arrived to collect it. It was not believed to be related to the school at all and follow up is being done to determine why it was discarded there. Officers arrested three males today on separate calls for warrants. The first was from a bike stop, the second was a warrant service at the male's home, and the third was a call of a male acting under the influence at a park. Officers also handed three traffic collisions. One was a felony hit and run where the driver hit a male in a wheelchair and then fled. Luckily the victim was not seriously injured. We are working on locating the suspect.

SUPERVISOR COMMENTS

An officer responded to a group home for a report of 3 juvenile runaways. Just after taking the report and entering them in the system, they returned back. When they returned they started a large disturbance with staff. They began to insult the staff members with profanity, spit at the staff, throw rocks, and attempt to fight with them. All 3 juveniles were 11 years old and considered "non-offenders" for arrest. Based on their actions and the danger they posed to the staff and other kids at the home, they were taken for a mental health evaluation. Officers also responded to a park to security check a male who was obviously assaulted. He had injuries to his face and possibly a broken ankle. The male did not remember what happened to him but claimed his wallet and phone were missing. He did not want to make a police report, but requested transportation to the hospital. The incident was documented and the male was advised to call if he changed his mind.

SUPERVISOR COMMENTS

This Friday night was a busy one. Officers started the shift with several calls holding. After briefing they started assisting swingshift in handling the calls. Tonight was the Harvest Bowl, and afterwards a large number of juveniles congregated at the In N Out restaurant. I assigned several officers to stay visible in the area and deter any issues from arising. Later in the night, officers were investigating a call of a female yelling on a city street. After officers were not able to locate the issue, a resident decided to walk out of his home, with a loaded handgun and flashlight. He started walking up to an officer who was parked in the street, shining the flashlight at the police officer while he held his loaded handgun in the other hand. A backup officer arrived on scene and as soon as he saw the loaded handgun, gave the male clear commands to drop the firearm, which he did. Turns out that the handgun was not registered, was loaded, and was clearly in public view. The resident stated he heard noises from his roof and was coming outside to "scare" whoever was on his roof. The firearm was taken and a report will be forwarded to the DA office for possible prosecution of having a loaded, unregistered handgun, in public.
